As Per NASBA standards, a nano learning course is a 10-minute, Electronic, Self-Study course in which you are eligible to earn **0.2 CPE credits**. Nano learning provides a unique opportunity to tackle new subjects, presented in bite-size learning modules, so you can earn quick CPE even when you're short on time.

However, Nano Learning is not acceptable by various State Accountancy Boards. If you are a CPA and looking for the CPE credits using Nano Learning, make sure that your double check the eligibility of Nano Learning CPE by your State Accountancy Board.
